EXPECTATIONS OF SUCCESSFUL CANDIDATES

- School attendance at or greater than 95% (no more than 5% unjustified absences)
- Active participation in all team trainings and games
- Meet with the Director of Sport or TiC of the extracurricular activity each term to discuss progress and future goals
- Submit all assessments and maintain positive grades
- Involvement in at least three sports or creative, innovative activities at Lynfield College which contribute to the wider life of the school, e.g. culture day, coaching, Human and Environmental Resource Group (HERG), leadership etc.)
- Maintain positive pastoral and behavioural records
- Remain at Lynfield College for the duration of their secondary school education
- Continued representation of the school in the chosen scholarship field (should representation cease the scholarship will be terminated and fees repaid on a pro-rata basis).

REQUIRED DOCUMENTATION AT THE TIME OF APPLICATION

- Cover letter outlining what attributes the applicant has to offer Lynfield College and why the applicant believes they should be awarded a **Sports or Creative, Innovative Scholarship** at the College

- Sports or creative, innovative subject achievements (must be evidence-based)
- Last two school reports (subject grades and comments)
- Sports or creative, innovative subject achievement over the past 12 months
- Sports or creative, innovative goals for 2020
- Sports or creative, innovative for 2021 and beyond.

SCHOLARSHIP SELECTION PROCESS

A selection panel (two of whom will be the Principal, and the Director of Sport and/or the Teacher/s in Charge of the extra-curricular activity), will meet to shortlist and then interview potential scholarship candidates. Families and scholarship applicants are expected to attend an interview.
